I agree to indemnify and hold harmless the Association and John Wieland Homes, Inc, its officers, directors, employees, agents and members, past, present and future for any and all claims, costs, causes of action and liability (including, but not limited to, attorney's fees) for any injury, to either person or property, suffered by me, my family members, employees, agents, servants, guests, invitees or any

member of the Association or any other person which arise from or are in any way related to the above activity, whether or not cause by the Association's negligence.

- 8. I assume all responsibility for the actions and behavior of all persons present at, attending, or in any other way related to my function and agree to be personally responsible for causing such persons to comply with the Association's Declaration, By-Laws and Rules and Regulations. I acknowledge that violation thereof by any person present at, attending, or in any other way related to my function may at the sole discretion of the Association's Board of Directors, result in forfeiture of my deposit.
- 9. I understand that I am being granted the exclusive use of the Clubhouse for the time period described above subject to the right herein reserved by the Association to enter the Clubhouse and terminate my use thereof should the conduct of any person using the facility endanger the health, safety or well-being of any person or constitute a threat of any property.
- 10. I am at least 21 years of age and will be in attendance at my function. I hereby agree and represent that the Clubhouse will be used for lawful purposes only and that if any conduct at the function I am sponsoring violates federal, state or local laws or ordinances, my rights to use the Clubhouse under this Agreement shall be terminated and the Association shall have the right to take possession of the Clubhouse and instruct my guests to leave the property.
- 11. In the event of cancellation of my reservation twenty-four hours or more before the reservation date, the security deposit and rental fee will be refunded in full. Cancellation after this time will result with a refund of the security deposit only.
- 12. Subject to those deductions provided for in this Agreement, the deposit will be refunded in the whole or in part by mail.
- 13. FACILITY CLEANING I agree to clean the facilities after use, including any and all necessary means to restore the Clubhouse to its prior condition, up to and including mopping floors, vacuuming and steam cleaning carpets, cleaning the kitchen and bathrooms and removing all garbage from the property.

14. POOL USE (check one) I WILL NOT be using the pool during my function I WILL be using the pool during my function (Separate Pool Reservation Required)

A. I understand that a pool reservation is NOT INCLUDED in this agreement and must be approved and reserved separately with the Carriage Park Pool Chairman. I further understand that I must hire an additional lifeguard(s) if necessary as required in the Carriage Park Pool Rules. All associated costs are my responsibility.
